

CHALLENGE

Arch Grants is a Missouri not-for-profit corporation. Their mission is to advance economic development through entrepreneurship. Each year, Arch Grants hosts a competition to attract applicants from around the world in competing for the opportunity to receive a \$50,000 grant in exchange for moving their businesses to the St. Louis area for one year.



Arch Grants has a small office with no Administrative support. They have 10 board members and an average of 25-40 pages of documents each board meeting where the board meets 10 times per year. Their board members are high-level professionals who expect timely and thorough meetings. With such detailed meetings, extensive preparation in advance was a major requirement. They had a lot to do with little help.

SOLUTION

Arch Grants started using BoardPaq in February 2015. Using BoardPaq, allows for staff members and volunteers alike to stay informed year-round with real time updates. Board administrators and members are able to view meeting information ahead of time and are given much needed preparation time before each meeting.

By going paperless, office efficiency has risen noticeably. Digitally managed meetings via BoardPaq resulted both in a more environmentally and economically friendly office.



Due to the app's adaptability, Arch Grants did not need to purchase any additional equipment, allowing users the comfort of viewing their documents on their own familiar devices.
